SUBJECT: Modern Award Draft Determinations

ATTENTION: Chief Executive Officer

Following the Fair Work Commission's (FWC) annual wage review on 1 June 2018, draft determinations varying Modern Awards have now been published on the FWC's website.

The draft determinations vary the minimum wages in each Modern Award, with the new wages taking effect from the first full pay period on or after 1 July 2018.

For those clients covered by the SCHADS Award, we confirm that the draft determination does not incorporate the equal remuneration order (**ERO**) adjustments. The rates, which incorporate the ERO adjustment, will be published separately by the FWO and we will advise clients once these rates are made available.

Clients with enterprise agreements may need to check their wages against the modern award rates as varied by the draft determination. Advice can be sought from SIAG on this matter.

We anticipate that the FWC will update the Modern Awards to incorporate the varied minimum wages by July 2018. SIAG will make these available once published.
